



## General Release

I, the undersigned, hereby grant the Metro New York Chapter of the National Black MBA Association (hereinafter “NMBBAA”), P.O. Box 8135, New York, NY 10116, the following rights:

1. I grant the Metro New York Chapter of the NMBBAA the absolute and irrevocable right and permission to record my likeness and/or voice with still photography, film, videotape, sound recordings, or any other medium (hereinafter “Photography”) on the date and at the location listed below.
2. I also grant the Metro New York Chapter of the NMBBAA the right to edit at its discretion, to use, publish, distribute, display, perform and license such Photography to third parties, in whole or in part, individually or in conjunction with other photographs, images or any copyrighted matter, for any lawful purpose, in any manner and medium, including but not limited to, advertising, publicity or promotional material, in print, video, television, radio, or any other media, electronic or otherwise, including web sites and the Internet, at any time or times throughout the world in perpetuity without notifying me, to copyright said Photography in its own name or otherwise, to use or authorize the use of quotations and soundtrack recordings of me or my voice, including the right to substitute the voice of another person or persons for my voice, to use my name or a fictitious name and biographical and other information, accurate or fictitious, concerning me in connection with the exhibition, advertising, exploitation, promotion or any other use of such Photography.
3. I hereby waive any right to inspect or to approve the Photography or the editorial or printed matter that may be used in conjunction therewith and further waive any claim that I may have with respect to the eventual use to which they may be applied, whether the use is known to me or unknown.
4. I agree that the Metro New York Chapter of the NMBBAA, or the Metro New York Chapter of the NMBBAA's agent, shall own the copyright in the Photography. If I should receive any print, negative or other copy thereof, I shall not authorize its use by anyone else.
5. I warrant and represent that this grant of rights does not in any way conflict with any existing commitment on my part. I have not heretofore authorized (which authority is still in effect), nor will I authorize or permit the use of my name, voice, quotation, photograph, image or likeness in connection with the advertising and promotion of any product or service competitive or incompatible with any product or service provided by the Metro New York Chapter of the NMBBAA.
6. I acknowledge that I will not receive any compensation for the grant of rights contained herein.
7. I hereby forever release and discharge, and agree to hold harmless the Metro New York Chapter of the NMBBAA and its agents, employees, licensees, successors and assigns from any liability for any violation of any personal rights, intellectual property rights or any other rights which I may have arising out of or in connection with the Metro New York Chapter of the NMBBAA's use of the license granted in Section 2 above.
8. I hereby warrant that I am of full age and have every right to contract in my own name in the above regard. This agreement shall be binding upon me, my heirs, legal representatives and assigns. I state further that I have read this General Release prior to its execution and I understand its terms.
9. I hereby authorize the Metro New York Chapter of the NMBBAA to allow for me to partake in any field trips that the Program has scheduled as part of the curriculum for the learning of the students in the program. This General Release will serve as my agreement to follow all rules and regulations associated with said field trip
